# EXECUTIVE TEAM MEETING (PLANNING & PROJECTS COMMITTEE AND STAKEHOLDERS)

#### TRRC Regional Plan Update:

Mr. Fjelstul asked Ms. Jeannie Brantley to begin the Executive Team Meeting. Ms. Brantley welcomed the members and thanked them for attending today's meeting. She then asked Mr. Paul Jarrell to present his portion of the update.

#### **Regional Needs and Opportunities**

Mr. Jarrell began by advising the attendees that the regional needs were gathered from the six (6) public listening sessions that were held throughout the region. The needs were listed under headings such as Transportation, Housing and Land Use, Economic Development, etc., and at the November committee meeting, the attendees were tasked with assisting to prioritize the regional needs. Each member received a copy of the TRRC Regional Plan Regional Needs and Opportunities for their perusal. Mr. Jarrell advised the members that the priority needs and opportunities would become a part of the work program portion of the Regional Plan Update. He also encouraged the Executive Team to submit any feedback to the TRRC Planning staff.

One of the *Economic Development* section's priority needs ("need for increased skilled labor") initiated a comment from Mr. Douglas Hollberg. He recently attended a Kiwanis meeting where Dr. Kirk Nooks, President of Gordon State College, mentioned a statistic concerning young adults (18 – 25 age bracket) in the region and the fact that only twenty-one per cent (21%) of the population has more than a high school education. This could impact new businesses that may want to relocate to the region. Mr. Hollberg suggested that Mr. Jarrell contact Dr. Nooks regarding education and information on how the college can collaborate with local schools to improve that statistic.

#### Discussion of Goals and Policies

Ms. Cymone Haiju advised the members that the goals are obtained from statewide recommendations while the policies are gathered from the past Comprehensive Economic Development Strategies (CEDS) and regional plans. Ms. Haiju placed the members in several different groups and assigned a topic (economic development, natural and cultural resources, transportation, community facilities, housing, etc.) for that group to review. The groups were asked to discuss among themselves the statements under their assigned topics and make any needed adjustments. At the end of the exercise, one representative from each group gave their report.

#### Discussion of Performance Standards

Ms. Kim Dutton presented this portion of the agenda. Due to time constraints, Ms. Dutton asked the members to review the Performance Standards as a "homework exercise" and to break down the standards into tiers (1, 2 and 3). The members were asked to submit this information to the Planning staff very soon.

Nothing was presented under this portion of the agenda.
