SUMMARY OF MEETING

The Three Rivers Local Elected Officials of the TRWDB Area 8 held a called meeting on June 23, 2022 at 2:00 p.m., at the Turin Town Hall, 47 Turin Rd, Turin, GA 30289.

Called to Order and Welcome

Chairman J. Briar Johnson called the meeting and welcomed everyone in attendance at 2:01pm. Roll called was taken and a quorum was present.

Approval of the Agenda

Chairman Johnson asked for a motion to approve the agenda.

Workforce Updates

Stephanie Matthews provided an update of West Georgia Technical College (WGTC) current performance as the Career and Youth Services Contractors. She stated that they are doing great with meeting performance.

She informed the LEOs that during last years' audit, Workforce had zero findings with the TRWDB audit and the Three Rivers Regional Commission annual audit.

Stephanie introduced the staff members who were present at the meeting to the LEOs.

Stephanie informed the LEOs that Workforce applied for additional funding with the following grants. She informed the LEOs that we were only awarded \$115,000 for the Sector Partnership Grant this year. She stated that last year we received \$366,000 for Sector Partnership. She informed the LEOs that all other state agencies received roughly \$100,000 from the State due to a decrease in

federal funding. She informed the LEOs that we applied for the Quest Grant to assist dislocated workers that were laid off due to Covid. She stated that she requested the full grant amount of \$700,000, and she's waiting for a response back from the State.

Other Business

Chairman Johnson asked for nominations for a new Chief Local Elected Official (CLEO).

Motion

Commissioner Norman Allen motion to reappoint Chairman J. Briar Johnson as the CLEO. Commissioner Michelle Morgan 2nd the motion. All agreed.

Chairman Johnson asked for nominations for a new CLEO Vice-Chair.

Motion

Mayor Douglas Hollberg motion to appoint Mayor Carlos Duffey as the new CLEO Vice-Chair. Mayor Charlene Glover 2nd the motion. All agreed.
