Adoption of the Minutes:

Youth Reports

Active Caseloads PY20 (OSY)

Kedra stated that Three Rivers Youth Services has a total of 119 OSY on their caseload and WGTC has a total of 105 OSY on their caseload.

New Registrations

Kedra informed the Committee members that we have 4 new Registrations.

Work Experience (WEX) PY20

Kedra stated that TRWDB Youth Services has a total of 2 OSY enrolled in the Work Experience (WEX) program in Meriwether County.

GED Enrollment PY20

Kedra stated that WGTC has a total of 69 OSY enrolled in the program.

Exits

Kedra stated that there are a total of 10 Participants' who exited the program.

Other Business

Kedra informed the Committee members that we purchased an Employment Readiness Training Program for the Youth Work Experience (WEX) Participants at a cost of \$7,000. The training tool will assist the WEX Participants, and other individuals with training needs to utilize the system.

Youth Services Policy
